2022 Nomination Procedures for Elected Offices

Nominations are open for the Alaska REALTORS® following positions:

President 2024	3-year term (2023-2025)	Nominations open to all Boards
Secretary/Treasurer	1 year term (2023)	Nomination open to all Boards
Small Board NAR Director	*3-year term (2024-2026)	Nominees ONLY from Fairbanks, Kachemak, Kenai, Southeast and Valley Boards
Medium Board NAR Director	*3-year term (2025-2027)	Nominees ONLY from Anchorage Board

Except the Secretary/Treasurer officer position, the President, Small Board Representative and Medium Board Representatives are NAR Director positions. Members seeking the NAR Director positions MUST "self-certify" their interest to serve as an NAR Director through the NAR certification link <https://gms.realtor.org/dirntitl.nsf/AddDirApp?OpenForm>

The nominees certified will be reviewed by the Alaska REALTORS Credentials Committee.

****Note: these terms are subject to change based on the August 17, 2022 drawing.*

The 2023 Election will be held electronically during the State Convention, September 21-24, 2022, with results announced at the General Membership Meeting on Friday, September 23, 2022.

Deadline to file for office is August 1, 2022

The Credentials Committee will review applicants in accordance to the qualifying criteria. Only REALTOR® Members shall be eligible to hold office in the association, provided, they have been a REALTOR® member for at least two (2) years prior to their term taking effect on the Board of Directors. All eligible candidates must have served as either an Officer or Director for a minimum of one year on a local Board and be a member in good standing. Circle one:
